- Corporate members can play every day of the week, excluding a Saturday and Sunday morning unless you are an allocated member.
- Handicap and affiliation fees are excluded in the price and will be applicable to allocated memberships only.
- To book your rounds, one person at your company will be responsible to make these bookings. You can contact the pro shop on 010 594 0034 or email at proshop@kyalamigolf.co.za
- As a corporate member your company name and logo will be displayed on our corporate membership board. Your company logo will also be displayed on one of the holes on the tee boxes. This will be based on a first come, first choice. This will be limited to 18 corpo rates. Once your package has been finalized a list of available holes will be sent to you for your selection.
- If you have selected to host a golf day as part of your package, a date can be decided at any given time. Please take note that shotgun starts will carry an additional charge due to the morning field slots that needs to be booked out. The cost of a shotgun start will be R45 000.00. You will be required to pay a deposit once you've booked a date. This is to secure the date and will be taken off your final invoice.
- As a Corporate Member, you shall enjoy a 20% discount on venue hire for any corporate function and conference.
- Corporate packages are valid for a period of 12 months and is renewable 1 month prior to your anniversary date.
- Members will always be subjected to the Rules of Kyalami Country Club with regards to Conduct, Dress code etc. We furthermore reserve the right to accept or refuse applications for Corporate Membership.
